1. A retainer fee is required to reserve the date. No date is reserved until the retainer is paid. Payments are set up into thirds with the first payment being the retainer. This retainer holds the date and is non-refundable in the case of cancellation by wedding party. The second payment is due one week before the wedding date. Remainder of balance will then be paid upon delivery of final product unless other arrangements have been agreed upon and noted on front page. Payment for Audition package is half of final price as the retainer and the second half due upon completion of video.
2. Upon your signature, CREATIVE EYE PRODUCTIONS reserves the time and date agreed upon, and will not make other reservations for this time and date. For this reason, all retainer fees are non-refundable if the wedding is canceled for any reason, or if the date is changed.
3. If we are unable to perform the services agreed upon for whatever reason, we will refund your retainer fee.
4. It is the responsibility of the client to secure permission of church, synagogue or other officials to videotape the ceremony. The retainer fee is non-refundable if such officials prevent videotaping.
5. CREATIVE EYE PRODUCTIONS will abide by the rules of the church or synagogue regarding camera placement at the ceremony. Permission of officiate is required before the camera(s) are set up.
6. The Original tapes remain the property of CREATIVE EYE PRODUCTIONS. The Client gives CREATIVE EYE PRODUCTIONS permission to use footage from the original tapes to market CREATIVE EYE PRODUCTIONS videography services.
7. CREATIVE EYE PRODUCTIONS will take utmost care to produce a tape of good quality. However, we will not be responsible for circumstances beyond our control, The Client agrees not to hold CREATIVE EYE PRODUCTIONS or its associates liable for any faults in tapes and/or footage caused by the actions or equipment (lighting/flashes, etc.) of other persons, reception halls, photographers/videographers (professional or otherwise), manufacturers or any circumstances beyond their control (weather, power failure, etc.) CREATIVE EYE PRODUCTIONS makes no guarantees, either expressed or implied, in regard to aesthetic qualities of the completed videotape.
8. CREATIVE EYE PRODUCTIONS is not responsible for poor audio if the groom does not agree to wear a lapel microphone, or for any interference that occasionally occurs with all wireless microphones. Placement of external microphones is dependent upon the cooperation of the site owner/operator and CREATIVE EYE PRODUCTIONS can not guarantee quality of audio without adequate positioning of external microphones.
9. Because CREATIVE EYE PRODUCTIONS is generally on the same schedule as the bride and groom, the client agrees to provide CREATIVE EYE PRODUCTIONS with a reasonable meal during the time that the bride and groom are served at the reception Creative Eye Productions. If the meal is provided out of the view of the reception activities, CREATIVE EYE PRODUCTIONS can not guarantee that any events occurring during the videographers absence will be captured.
10. CREATIVE EYE PRODUCTIONS reserves the right to discontinue videotaping in any situation (ex. Rain, extreme temperatures, humidity, hazardous locations) that could put the safety of the videographer or equipment at risk.
11. The client must notify CREATIVE EYE PRODUCTIONS of any typographical errors within 48 hours of receiving the finished video. CREATIVE EYE PRODUCTIONS will correct any such errors at no charge to the client. Otherwise, the video will be considered a finished product, and any additional requested revisions will be added to the client's balance at the prorated rate of \$100 per hour.
12. Under any and all circumstances, CREATIVE EYE PRODUCTIONS' liability is limited to the refund of the retainer fee.
13. CREATIVE EYE PRODUCTIONS reserves the right to use portions of the videotape for promotional or other purposes.
14. Any special requests overriding the terms and conditions of this contract must be specified in Wedding Service Agreement prior to the wedding date.

I hereby state that I have personally viewed examples of Creative Eye Productions prior work and therefore approve of and agree to abide by the creative decisions in the videotaping process by Creative Eye Productions. In the result that I have chosen not to view prior work by Creative Eye Productions I still agree to abide by those creative decisions by Creative Eye Productions. I have also read the terms of this agreement and accept the conditions as listed.
